ARTICLE I - OFFICES

Sec. 3. COMPLIANCE WITH STATE AND FEDERAL LAW. NOW, THEREFORE, the Comanche Cove Owners Association Inc., does hereby adopt and establish this amendment to the Bylaws.

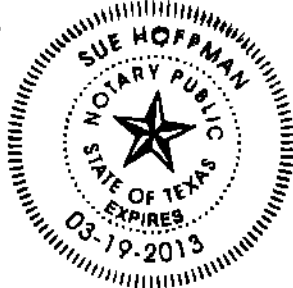
